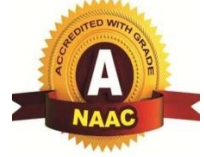

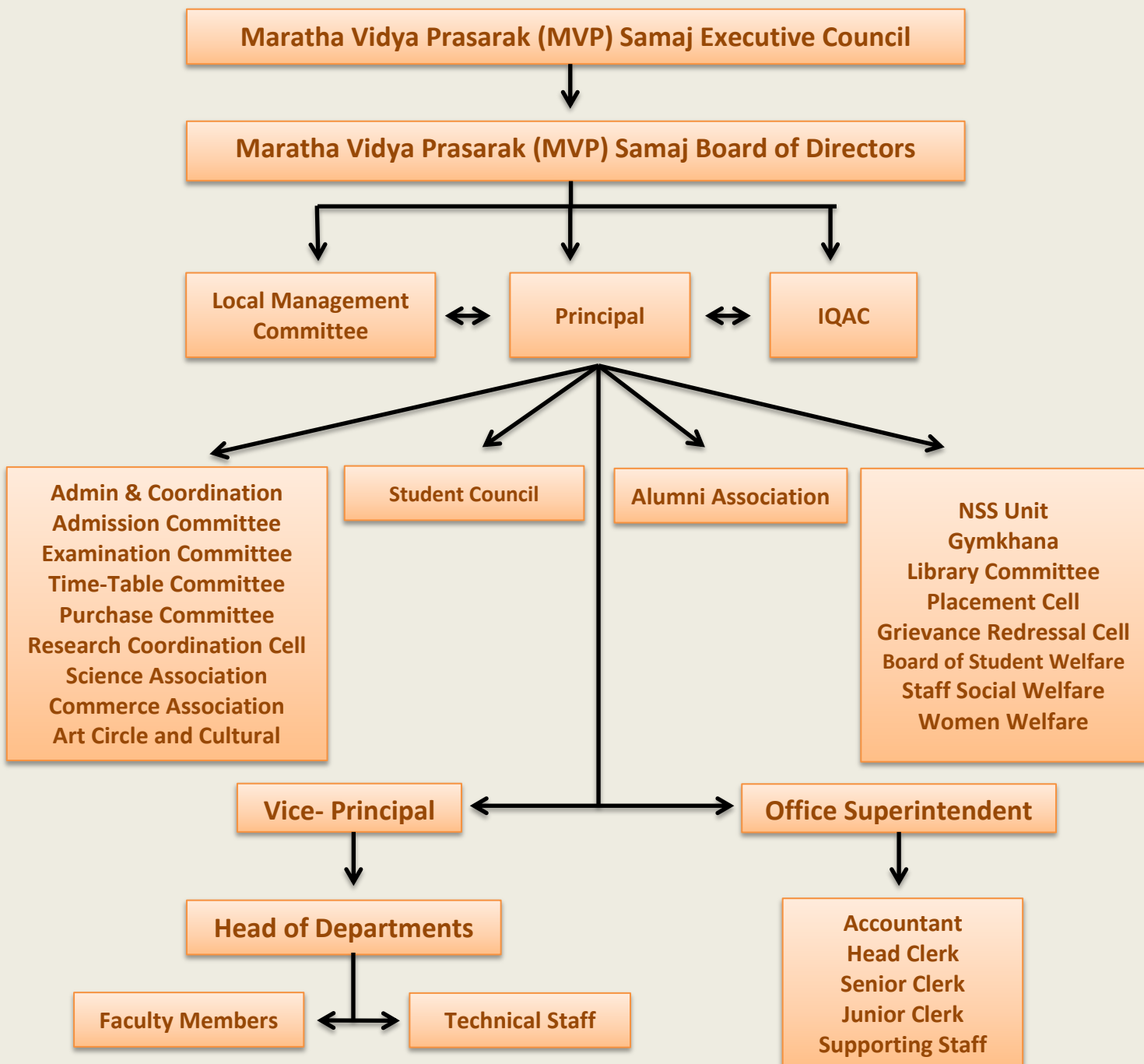

### 6.1.1- Decentralization and Participative Management

MVP's ACS College Nandgaon believes in involving all the directors in the decision making process for better outcome and thus practices decentralization at all levels of decision making. The college has a well-designed organizational structure to facilitate involvement of all the directors in the various activities of the college. Principal is the head of the college and skillfully aided by various committees at the college to facilitate decision making. All the departments are headed by Heads. Various Teaching and non-teaching committees are established at the college and the constituent units consisting of staff members from various segments and relevant directors to obtain the feedback and facilitate decision making process.

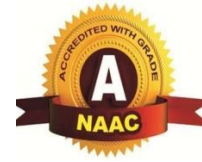
Some of the examples for decentralization and participative management:

#### **Participative Management:**

At the college level, various committees are constituted with members from all the faculty to facilitate collective and participative decision making process. The management decides on the goals and roadmap which is communicated to the heads of the institute. The objectives and goals are communicated to the entire faculty and heads of the department discuss them during the departmental meeting to set the targets for individual faculty and department. The achievement statuses of these objectives are regularly monitored through audits at the college level.

#### **Financial Administration:**

At the college level, principal consolidates the budget requirements of the institute. Top management along with heads of institution deliberates on the proposal and the budget is allotted based on the available resources. Based on the budget amount allotted, the head of the institution in consultation with the head(s) of the department may fine tune the budget, if necessary. Once the budget is allotted, the departments are communicated regarding the same and head of the department is entrusted with the procurement of sanctioned items as per the budget.



### Academic Activities:

Academic administration involving implementation of university syllabus and Academic calendar and time tables for regular courses are prepared at the college level which is circulated to all the departments. At the department level, the allotted time is utilized to plan the delivery of academic content and is assigned to respective faculty. The delivery of academic content is Monitor by head of the institute. The college plans and organizes the internal assessment examination during the academic year whereas the university examination is conducted by the university. The university supports the institution by providing the question papers, list of internal examiners and external examiners and the facilities needed to organize the exam.

### Research activities:

College encourages the entire faculty to contribute to the research excellence. Research Committee is established at the university level with representatives from the entire faculty for their participation in formulating research objectives, monitoring of research activities and their progress, and to communicate research opportunities to the entire faculty. All the faculty are provided with financial support and research incentives to conduct research, publish their research in reputed journals and to attend conferences at national and international forums. The college also support communicates active grant proposals and facilitates grant applications. The performance of the staff and its participation in achieving the goals and objectives of the college are assessed through performance appraisal. The faculties are evaluated at the department level by Head of the department whereas head of the department are evaluated by head of the college. Similarly, performance assessment of non-teaching is also conducted every year.

### Student Activities:

All the student related activities such as co-curricular, extra-curricular and social activities are organized and mentored through staff coordinators. Students are participating in

About Saumitra Food Industry,

Vegetable are the most essential commodity which is daily utilized in every houses and hotels but it is most perishable items. Many time due to excessive cultivation, vegetable get very meager prize in the market and are thrown as debris. Considering this tremendous loss of poor farmers, Mr. G R Kulkarni, established vegetable processing and dehydration unit in the year, 2013 at Ozar which saved vegetables and are sold in India as well as exported in many countries.

### 1) Objectives of MOU

- a) To promote and enhance the academic interest between college and industry
- b) To foster the self employability among the students
- c) Industrial training for the students about food processing and vegetable dehydration
- d) Industrial visits and guidance to the students of Nandgaon College.
- e) Guest lecture of industrial executives to the students of Nandgaon college

- f) Use of industrial board for the practical in the department of Botany
- g) Campus placement as per the industrial requirement to the Nandgaon college students
- h) To sponsor the industrial projects to the college students
- i) To provide the trained manpower from the college to the industry as and when required

## 2) Technical areas of collaboration

- a) A continuing the quality improvement program to improve the quality of teaching with industrial expertise
- b) To conduct the short term certificate courses in the food processing and dehydration of perishable vegetable food products
- c) To provide the academic interaction between the food industry and college for the student's benefits
- d) To provide the necessary help in organizing workshop / conferences and industrial training for the enhancement of skills in respect of faculty, staff and students of the college.
- e) To provide the necessary support for the establishment of food processing unit in the college, Training and placement
- f) To facilitate the training for the teachers and supporting staff
- g) Guidance for the infrastructure development of the college.

#### **4) Terms and Conditions**

- b) The training of the food processing in the Saumitra food industry should be borrowed by the college it self
- c) For visit related to advice and consultancy , travel and other expenses of the teachers and students shall be reimbursed by Nandgaon college
- d) Use of industrial recourses and infrastructure can be allowed for the limited period of time and availability of industrial row material
- e) Both Nandgaon College and Saumitra food industry agree to help identify and invite the faculty members and researchers from the other institutes to participate in the conference, seminars industrial training and short term courses conducted by the college
- f) This MOU may be amended, renewed and terminated by mutual written agreement of the institute at any time
- g) Either institute have an right to terminate this MOU up on 60 days prior written notice to the other institute



- e) Both Nandgaon College and Forest department, Nandgaon agree to help identify and invite the faculty members and researchers from the other institutes to participate in the conference, seminars industrial training and short term courses conducted by the college
- f) This MOU may be amended, renewed and terminated by mutual written agreement of the institute at any time
